MAIN PURPOSE AND SCOPE OF THE ROLE

You will be a key part of the Inside Out delivery team with responsibility for supporting wellbeing and building emotional resilience with participants with a view to helping them to look for and return to work or training. You will manage your own time, be pro-active in developing and delivering activities and courses and form a clear understanding of the compliance requirements of the project.

TASKS AND RESPONSIBILITIES

- Facilitate the delivery of accredited and non-accredited training and development as part of the Inside Out Project, working as part of the Project delivery team
- Support Inside Out participants with their wellbeing on a 1-2-1 basis, coaching and mentoring them to build resilience and confidence to return to training and/or work
- Co-ordinate the administration and delivery of wellbeing activity, working closely with the Community Coach.
- Ensure service is delivered in line with budget and in compliance with funder requirements
- Attend appropriate meeting both internal and externally to built excellent partnerships.

- Respond in a timely manner to all incoming communications
- Maintain training materials, update database, outcome data, & relevant documentation to ensure accurate recording of courses.
- Attend monthly service delivery meetings with Project Manager to update delivery on delivery.
- To take telephone and emails messages for CLEAR relating to the delivery of Inside Out (Coast to Coast)
- Organise, prepare and deliver training materials and lesson plans and evaluate the impact and outcomes of delivery
- Work with local employers to promote Inside Out and the Inside Out participants, securing opportunities for work placements and employment
- Help businesses who participate in Inside Out to support wellbeing at work
